

## Anchor Bar Sweepstakes Official Rules

2. **Eligibility:** Entrant must be a legal resident of New York who is 18 years or older. Officers, directors and employees of Sponsor, their respective parents, subsidiaries, affiliates, advertising and promotion agencies, and their family or household members (defined as parents, spouse, children, siblings, and grandparents) are not eligible to enter.
